Psalms 34:18 assures, "The LORD is nigh unto them that are of a broken heart; and saveth such as be of a contrite spirit." Counseling enters brokenness with hope anchored in God's nearness. The goal is not symptom management alone but repentance, faith, and conformity to Christ.

2 Timothy 3:16-17 declares Scripture sufficient to equip the man of God thoroughly for every good work—including soul care. Biblical counseling does not deny medical or legal resources but insists that ultimate heart change requires Spirit-applied truth, not merely behavioral techniques.

Systematic Connections

Doctrine is interconnected. A shift in bibliology eventually alters soteriology; a flawed Christology undermines assurance; pneumatology affects worship and ethics.
