The Sermon on the Mount (Matthew 5-7) internalizes obedience: anger can murder, lust can adulterize, oaths must yield to simple truthfulness. Jesus fulfills the law rather than abolishing it; His kingdom ethics exceed Pharisaic externalism while remaining grounded in Torah's moral heart.

Systematic Connections

Doctrine is interconnected. A shift in bibliology eventually alters soteriology; a flawed Christology undermines assurance; pneumatology affects worship and ethics. As you study **Ethics Capstone Position Paper**, map at least three connections to other loci (doctrine areas). Use cross-references in a chain reference Bible or equivalent study tool.
