Peter explains that prophecy never came by human will, "but holy men of God spake as they were moved by the Holy Ghost" (2 Peter 1:21). Inspiration is therefore not mechanical dictation but Spirit-directed composition. The human author is fully active; the divine author is fully sovereign. This union explains why Luke can investigate sources (Luke 1:1-4) while still writing Scripture, and why Paul's pastoral heart shines through his letters without diminishing their authority.

Psalm 119 celebrates the perfection and permanence of God's Word: "Forever, O LORD, thy word is settled in heaven" (v. 89). Jesus affirmed the indestructibility of Scripture when He said, "Till heaven

and earth pass, one jot or one tittle shall in no wise pass from the law, till all be fulfilled" (Matthew 5:18). These texts support the doctrine of inerrancy in the autographs and the faithful preservation of the message through manuscript transmission.

Systematic Connections

Doctrine is interconnected. A shift in bibliology eventually alters soteriology; a flawed Christology undermines assurance; pneumatology affects worship and ethics. As you study **Presuppositions Capstone: Written Method Statement**, map at least three connections to other loci (doctrine areas).
